WIVETON CHURCHYARD:

MONUMENTAL INSCRIPTIONS AND PLAN OF BURIALS

People who visit a graveyard to feel the beauty and sadness of the place need know nothing of those who lie there. Even so, a chance find among the inscriptions, an accidental death, perhaps, or several children together, can add to the poignancy of the occasion. For others it is the search for ancestors or other relations which is the cause of the visit. For this purpose an accessible plan of the graveyard and a listing of the stones it contains can be particularly useful. This article presents such a plan and listing for the churchyard at Wiveton.

The Inscriptions

In 1885 Walter Rye published a list of all the monumental inscriptions in Holt Hundred collected by Walton Dew, some time resident of Blakeney. Dew's survey appears to have covered all inscriptions, whether on stone or brass, both inside and outside the church, but however detailed his notes the publication rarely contains the full text of the inscription. Nevertheless, it is valuable to have such a record, as some of the information to be seen at the time has already been lost: either the letters have weathered beyond recognition or else the stone has disappeared.

Almost a century later, the Women's Institutes throughout England were encouraged to record in detail all churchyard inscriptions; with time taking its toll a full record ought to be made for posterity. So in 1976 a survey was done of 'God's Acre' in Wiveton: a full list was compiled and a map drawn. The inscriptions were recorded exactly as they appeared on each stone, and the findings are held by the Wiveton Churchwardens.

For this article a third survey has been completed to note all additional inscriptions made between 1976 and 31 December 1999. This new survey covers both the old churchyard and the new burial ground in Mill Lane consecrated in the 1950s. The three tables which follow the text represent three of the four areas where inscriptions are to be found: one table for the old graveyard, one for the new burial ground, and one for the cremation plaques which have been inserted into the wall of the old churchyard just inside the gate. Inscriptions inside the church represent a fourth group but these are not covered in the present article.

The **first table** is ordered by surname and gives the date of death and the age of each person commemorated in the graveyard. Each stone has two numbers, one given by the W.I. survey and one by Walton Dew / Walter Rye. No new stones have been erected since the 1976 survey. The table also contains some additional notes, mostly of three kinds: interesting facets on a person's life or death, the existence of a separate footstone, and apparent discrepancies between the three surveys. It does not include the *full* inscriptions, which can sometimes give so much help to genealogists, as this would take up too much space, but this information can be obtained from the Churchwardens.

Most of the personal comments relate to military or public service, or to loss at sea. Two members of the Cooper family, for instance, were washed overboard from merchant vessels, just five years apart; James Ratcliffe spent 25 years in the Life Guards and fought at Waterloo. The footstones noted in the table are those which have been removed from their original positions to lie against the church or churchyard walls, and which can be identified from the initials and date carved on them (FS in the table). Several of Dew's records differ from those in the W.I. survey. Such cases have been checked and those where Dew is in error are noted in the table ('X Dew'). Mostly these are misreadings of the day or month element of the dates but sometimes a year has been recorded incorrectly or else a name misread. On his stone 20, for example, he (or his editor) misreads Unah as Uriah. In one or two cases it is the W.I. survey which seems to be in error or else incomplete. In one case both surveys misread a name; on his stone 8 Dew records the name Elizabeth whereas the W.I. has Ella. The true reading appears to be 'Eleanor', inscribed as ELEANOR although the burial register gives Ellen! Finally, in three cases there is so much doubt about the year of death that the burial registers have again been checked, showing that Esther Bell did die in 1839 (not 1859), that Ann Drake Girdlestone died in 1854 (not 1851) and that Elizabeth Cademy died in 1845 (as in Dew's record) not 1846 as it appears to be on the stone. No other such checks have been made, except for Dew's stone 32 where his record of the date is correct.

Two stones recorded by Dew no longer exist (no. 70 for Ann Boyce and no. 25 for Frances Clarke) so anyone searching the graveyard for these stones with Dew's text in hand will be disappointed. One stone has sunk so far that little of the inscription remains above ground.

The **second table**, for the Mill Lane churchyard extension, lists just names, dates and ages. One inscription (Robert Grant, 1901) pre-dates the opening of the new burial ground. An asterisk against a name indicates that the (approximate) age of the person has been calculated from dates given on the stone. This also applies on the **third table** listing the cremation plaques (average age 78!).

It is evident from walking round the churchyard that few stones date from the eighteenth century. The table below shows the number of inscriptions (not stones) per decade.

Only 6 names pre-date 1780 (unless some have been lost) and just 32 names follow in the next 60 years to 1840. Then comes a big increase: 115 in the 60 years to the end of the 1890s, with the rise really starting in 1845, and the 1850s having the largest decade total.

This may prompt questions about the practice of erecting stones in churchyards. Beginning in the late 16th century, it was only the wealthy who could afford to erect stones but the figures suggest that either 'fashion' was at work or else that the 1840s and 1850s were a time of local prosperity. Such questions are outside the scope of this article but it may be of interest to compare the number of people buried in Wiveton (though not necessarily resident there) with the number commemorated on stones in selected decades:

Churchyard Plan

The plan of Wiveton churchyard is drawn from a survey prepared on behalf of the Society. The location of the stones is based on the W.I. survey of 1976 and the stone numbers are as used for that survey (not those given by Walton Dew). The stone positions are not plotted exactly but are sufficiently accurate to enable any particular stone to be quickly found.

Four of the gravestones (nos 123 – 126, circled on the plan) are 'listed' as being of historic interest – they are the four earliest. One records two members of the Bond family, while the other three carry the name of Smith. This family, including Thomas the millwright, was prominent in Wiveton in the 17th and 18th centuries and is the subject of a separate article in this issue of the Journal.

The churchwardens hold some extra information to the effect that certain children or families are buried near particular stones, and village memory can sometimes offer the names of those buried in unmarked graves.



War Memorial




Cremation plaques






Broken stone
